This is to advise you that in association with the review of Air Mail Facilities (AMF) and Air Mail Centers (AMC) nationwide, operations at AMC/AMF/ATO's will be standardized.

All piece distribution, mail assignment, and opening unit activities will be relocated to the appropriate processing and distribution center or other postal facility off airport. The AMC/AMF/ATO's will be returned to their core processes.

Any impacts to staffing will be addressed at the district and area levels and will be handled within the provisions of the Collective Bargaining Agreement.
